Comments should be directed to the entire Board, not individual members. Verbal attacks or comments intended to insult, abuse, malign or slander any individual shall be cause for termination of speaking privileges and expulsion from this meeting.)
2. Board member announcements;
3. Consider approving minutes of meeting for March 4, 2019;
4. Consider approval of Audit Report for fiscal year ended December 31, 2018 and take any necessary action;
5. Hear bookkeeper's report, investment report, and approve payment of bills;
6. Hear operator's report, consider and approve any permits, and take any necessary action;
7. Review Identity Theft Prevention Program, consider approving Order Reviewing and Confirming Identity Theft Prevention Program and take any necessary action;
8. Review, confirm or revise Drought Contingency Plan and/or Water Conservation Plan, as appropriate;
9. Hear engineer's report, consider approval of any change orders, authorize any advertisements for bids or the award of any contracts, consider approval of capacity requests and take any necessary action;
10. Discuss acquisition of easements for Zircon/MUD 51 areas and take any necessary action;
11. Hear Kemah Volunteer Fire Department presentation;
12. Consider amending Rate Order and take any necessary action;
13. Review tax assessor-collector's report and take any necessary action;


14. Discuss future agenda items;
