Notice is hereby given that Galveston County Water Control & Improvement District No. 12 will hold an election for the District on November 3, 2020, between the hours of 7:00 a.m. and 7:00 p.m. at the Galveston County Election Precinct Polling location(s) listed on Exhibit "A" for the purpose of electing three (3) directors of the District.

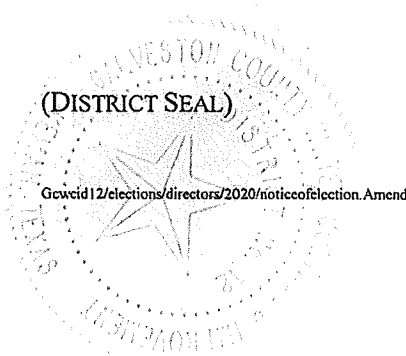
Early voting in the election by personal appearance shall begin on October 13, 2020 and shall continue through October 30, 2020. The polling locations at which such early voting shall be conducted are to be determined by Galveston County, which are tentatively listed on the attached Exhibit "B". The main early voting polling place is located at 600 59th Street, 2nd Conference Room, Galveston, Texas. The early voting clerk shall keep the early voting places open according to the schedule set by Galveston County. Election judges and clerks, both for early voting and for Election Day, shall be selected and compensated by Galveston County.


Applications for ballots by mail must be received no earlier than January 1, 2020 and no later than the close of business on October 16, 2020. Spanish language assistance to voters will be available by contacting the Early Voting Clerk or the Presiding Judge.



Mediante el presente aviso se informa que el Distrito No. 12 de Control de Aguas y Mejoras del Condado de Galveston celebrará una elección para el Distrito el día 3 de noviembre de 2020, entre las 7:00 a. m. y las 7:00 p. m., en los centros de votación de los Recintos Electorales del Condado de Galveston enumerados en el Anexo "A", con el fin de elegir a tres (3) directores del Distrito.
