

## NOTICE OF ELECTION

### TO THE QUALIFIED VOTERS OF GALVESTON COUNTY WATER CONTROL & IMPROVEMENT DISTRICT NO. 12:

Notice is hereby given that Galveston County Water Control & Improvement District No. 12 will hold an election for the District on May 7, 2016, between the hours of 7:00 a.m. and 7:00 p.m. at the Galveston County Election Precinct Polling location(s) listed on Exhibit "A" for the purpose of electing three (3) directors of the District.

Early voting in the election by personal appearance shall begin on April 25, 2016 and shall continue through May 3, 2016. The polling locations at which such early voting shall be conducted are to be determined by Galveston County, which are tentatively listed on the attached Exhibit "B". The main early voting polling place is located at 600 59th Street, 2nd Conference Room, Galveston, Texas. The early voting clerk shall keep the early voting places open according to the schedule set by Galveston County. Election judges and clerks, both for early voting and for Election Day, shall be selected and compensated by Galveston County.




Spanish language assistance to voters will be available by contacting the Early Voting Clerk or the Presiding Judge.
